### LETTER OF INTENT (LOI)

The eligibility criteria, terms and conditions and the enclosure requirements are delineated as follows:

#### **Eligibility:**

1. Experience in Fish Farming for a minimum period of 3years.
2. Active Bank account in the name of the Individual/ society/ Firm.
3. PAN of the Individual/ society/ Firm.

#### **Terms & Conditions**

1. A Rs.10,000/- upfront deposit is required. If the committee does not approve the early money deposit of Rs. 10,000, the funds will be reimbursed.
2. The highest bid amount quoted will be given preference, subject to approval by the competent authority.
3. The lease shall be granted for a period of three (3) years.
4. The pond shall be utilized exclusively for fish cultivation purposes.
5. The selected bidder must enter into a formal agreement/Memorandum of Understanding (MoU) with the authority.
6. Either party may terminate the lease agreement by providing a prior notice of six (6) months.
7. The lessee shall not construct any temporary or permanent structure on or around the water body without prior approval from the competent authority.
8. The lessee shall deposit the lease amount annually in the designated University account, as per the terms of the agreement.
9. University will have right to use water body area for water sports and related activities.

**Note:** The authority reserves the right to accept or reject any or all bids without assigning any reason thereof.
